Innovation Ohio 2017-2018 Working Families Scorecard Bills Used in Scoring

HB 1 – Dating Violence Prevention (Enacted into Law; effective 7/6/18)

Extends domestic violence civil protections and access to domestic violence shelters to anyone currently or formerly in a dating relationship. Votes are for the bill's final passage.

House Vote: 2/28/2018

Innovation Ohio supports a YES vote.

HB 26 - State Transportation Budget - Public Transit Funding Amendment (failed)

This amendment to the state transportation budget would have provided \$43 million per fiscal year for public transportation through the Federal Highway Administration (FHWA) flexible funding program. Votes are in response to a motion to table the amendment.

House vote: 3/1/2017

Innovation Ohio supports a NO vote on the motion to table.

HB 26 – State Transportation Budget, Automatic Voter Registration Amendment (failed)

This amendment to the state transportation budget would have required the state to register customers to vote when apply for a driver's license or state of Ohio identification card unless they opt out. Votes are in response to a motion to table the amendment.

House vote: 3/1/2017

Innovation Ohio supports a NO vote on the motion to table.

HB 27 – Workers' Compensation Budget (Enacted into law; effective 9/29/17)

Decreases the amount of time a worker has to begin a workers' compensation claim (to 1 year). Decreases the amount of time a firefighter diagnosed with job-related cancer has to claim worker's compensation (from 20 years to 15 years). Votes are for the bill's final passage.

House vote: 6/28/2017

Innovation Ohio supports a NO vote.

HB 36 – Pastor Protection Act (Passed in House)

Extends the right to discriminate against LGBTQ and others in the use of otherwise public accommodations owned by religious entities. Votes are for House passage of the legislation.

House vote: 6/27/2018

Innovation Ohio supports a NO vote.

HB 49 – State Operating Budget, Medicaid Coverage Amendment (failed)

This amendment to would have preserved continued coverage for the Medicaid expansion group (Ohioans age 19 through 64 with incomes at or below 138% of the federal poverty level), reversing language added by a House committee to freeze the program to new & returning enrollees. Votes are in response to a motion to table the amendment.



House vote: 5/2/2017

Innovation Ohio supports a No vote.

HB 114 - Renewable Energy Requirements (Passed in House)

Eliminates the state's targets for the share of generated electricity that must come from renewable sources. Votes are for House passage of the legislation.

House vote: 3/30/17

Innovation Ohio supports a NO vote.

HB 123 - Payday Lending Reform (Enacted into law; effective 10/29/18)

Reforms short-term or payday lending laws to cap the maximum amount that can be borrowed, the length of such loans, the fees that can be charged on such loans and caps the interest rates charged to an annualized rate of 28 percent. Votes are for the bill's final passage.

House vote: 7/24/2018

Innovation Ohio supports a YES vote.

HB 142 – Concealed Weapon Duty to Notify (Passed in House)

Loosens current law that a concealed handgun licensee or active duty military member "promptly notify" a law enforcement officer. Reduces criminal penalties for failing to notify of concealed carry handgun. Votes are for House passage of the legislation.

House vote: 10/24/2017

Innovation Ohio supports a NO vote.

HB 214 – Down Syndrome Abortion Ban (Enacted into law; effective 3/23/18; blocked by court injunction)

Criminalizes abortion if there is a positive test or prenatal diagnosis of Down syndrome. Votes are for House passage of the legislation.

House vote: 11/1/2017

Innovation Ohio supports a NO vote.

HB 233 - Concealed Carry Amnesty (Passed in House)

Decriminalizes violation of carrying a licensed concealed weapon into a place prohibiting concealed weapons. Votes are for House passage of the legislation.

House vote: 7/16/2017

Innovation Ohio supports a NO vote.

HB 456 - Nursing Overtime Ban (Passed in House)

Prohibits hospitals from requiring nurses to work overtime. Votes are for House passage of the legislation.

House vote: 6/7/2018

Innovation Ohio supports a YES vote.
